Dear Senator Schuring,


This is to confirm our conversation of January 25, 2008 concerning our scheduling a mediation between Republic Services of Ohio and the Stark County Board of Health, where we would also request the presence of a representative from the Governor's Office, the Director of the Ohio Environmental Protection Agency, Mr. Held from the Solid Waste District, and of course, yourself. We can add or subtract invitees as appropriate.

I have a hearing now scheduled for February 22, 2008 at 1:30 p.m. I will continue this matter until we have arrived at a date for our mediation.

As we spoke of the 25th, the early part of March (after March 4th) appears to be agreeable, and since you will be speaking with the Governor's Office and the OEPA, I will hold off scheduling a date until you contact me. I would think a full morning or afternoon (four to five hours) would be appropriate for the initial meeting.
